ANNUAL RETURN OF MEMBERS. A Return becomes due each year and will be emailed to you, in the first instance. It should be checked, updated and returned, in its entirety (via your Provincial Grand Scribe E if applicable), duly signed and accompanied by a remittance for the appropriate Annual Dues. We recommend that the following email addresses are added to your safe senders list: acroci@ugle.org.uk and registration@ugle.org.uk. The full amount is payable for every Companion whose name appears on the Return, whether they are clear on the Chapter books or not and includes those whose membership commenced or ceased during the year covered by the Return.

REGISTRATION FORM P. This form requires all the relevant information to be completed to enable the successful registration of a member. Once completed, it should be forwarded (via your Provincial Grand Scribe E if applicable), **immediately after their admission**, with the appropriate and current fee. This form is now available electronically and can be obtained by emailing your Provincial Office <u>or registration@ugle.org.uk</u>

In the case of a candidate who is a member only of a Lodge or Chapter <u>not</u> under the English Constitution, the Certificate of Eligibility previously issued by the Grand Scribe E. in accordance with Royal Arch Regulation 67 must be attached.

LP&A4 (**INSTALLATION RETURN - PRINCIPALS AND PAST PRINCIPALS**). The LP&A4 form must be completed and returned **immediately after the Installation Convocation**. This form is available electronically and will be emailed to you shortly before the Installation Meeting.

It is **imperative** that when sending in a hard copy of the relevant form or letter (if applying for a Replacement Grand Chapter certificate) you clearly state that payment for SGC has been made by bank transfer and provide relevant details i.e. the amount paid, date and reference used.
